Membership Application

Contractor and Associate definitions are as follows:

Contractor Member

Any firm, partnership, corporation or joint venture engaged in highway and heavy construction as a bona fide contractor, shall be eligible for contractor membership, provided that the following shall not be eligible for contractor membership:

- Persons engaged in Construction as an owner or government agency.
- Contractors that are wholly or substantially owned or controlled by an owner of government agency.
- Contractors engaged in construction but not operating as in the business for profit.
- Contractors that are not signatory to GCA Collective Bargaining Agreements.
- Contractors that do not employ unionized labor

Contractor Members are liable for dues as provided in the By-Laws, and are required by the Constitution to pay into the Heavy Construction Industry Fund (HCIF) the per-hour contribution set by the Annual Meeting for all labor hours-worked in New York City heavy construction or under the Collective Bargaining Agreements of the Association.

Heavy construction projects are hereby defined as including but not limited to, new construction or the inspection, rehabilitation or expansion of an existing structure or facility involving any aspect of subsurface construction or excavation; all construction from excavation through final completion of: engineered structures, parking garages, mass transit facilities including but not limited to bus depots, ventilation plants, maintenance shops, transit yards, stations, tunnels, railway lines and work along railway rights of way, highways, roads, streets, bridges, piers, wharves and bulkheads, airport runways, access roads, airline terminals, water and wastewater conveyances, including but not limited to tunnels, and associated facilities including gatehouses, pumphouses, valve chambers, and water and wastewater treatment plants, power plants, power generating stations, electrical substations and pipelines; all excavation and site-work, including but not limited to all installation, relocation or removal of utilities, all drainage, landscaping and paving; removal of hazardous materials as it pertains to heavy construction projects; and any construction commonly associated with "public works," "infrastructure" or "heavy civil" construction.

The annual dues of Contractor Members with an annual business volume of \$1,500,000 or more shall be \$1,560 per annum. The annual dues of Contractor Members with an annual business volume between \$300,000 and \$1,500,000 shall be \$720 per annum. The annual dues of Contractor Members with an annual business volume of \$300,000 or less shall be \$360 per annum.

Associate Member

Individuals, firms or corporations engaged in a business or profession which includes furnishing of services, equipment, materials or other supplies for heavy civil/public works construction, shall be eligible to apply for Associate Membership. Associate Members dues are \$750 per annum.

Dues are paid on an annual basis and must be paid within thirty (30) days of receipt of invoice.

A portion of the membership dues may be allocated to the GCA Political Action Committee upon consent of the member.

The Heavy Construction Industry Fund contribution is \$0.30 per hour, effective July 1, 2015.

Any member of the Association, whose dues or Heavy Construction Industry Fund Contribution shall remain unpaid for a period of three (3) months, shall forfeit the privilege of membership. If such member neglects to pay the dues within thirty days (30) thereafter, and after notification by the Managing Director, the name of such member may be stricken from the roll of membership by the Executive Committee. The Executive Committee shall, however, have the right to reinstate for good and sufficient reasons. Resignation of membership shall be made to the Association in writing. Such resignation shall not be accepted until all indebtedness to the Association has been discharged.
